



REGULATION OF THE INTERNATIONAL FOOTBALL BASED TOURNAMENT.

TIBAU DO SUL CITY - RN.

CHAPTER I

CONSTITUTION

Art. 1 - Objectives: I - Its purpose is to develop sports exchanges and provide good relations between leaders, coaches and athletes, establishing a secure union between sportsmen, community, associations and the Public Power. The objective is to exalt the practice of sport as an essential instrument for the formation of personality, creating a social integration of this with the sport in a way that can become participatory and bringing new values to the sporting scene Municipal, State, National and International.

II - To value sports practice as a way of quality of life.

CHAPTER II

OF PROMOTION AND ORGANIZATION

Article 2 - INTERNATIONAL FOOTBALL BASED TOURNAMENT will be held on October 12 to 14, 2018, and will be promoted in accordance with this regulation.

Art. 3 - TIBAU PIPA CUP will organize the tournament, including:

I - Promote the dissemination of the event;

II - To take the necessary technical measures, necessary for the good progress of the competition.

Art. 4 - The disciplinary committee will be composed of 04 (four) invited members and volunteers and will be responsible for:

I - Receive, analyze and approve the registration of teams, representatives of teams and athletes;

II - Analyze and homologate the results of the games, in view of the summary signed by the referee;

III - Apply, ex officio or on request, penalty to athletes, to team representatives, under the terms of this regulation;

CHAPTER III

CATEGORY AND PARTICIPANTS

Art. 5º - TOURNAMENT OF INTERNATIONAL OF BASE FOOTBALL, will have all basic categories:

Paragraph 1 - Athletes from 8 years old up to 20 years old can participate in the international tournament, divided into categories and groups:

1 Group 8 - 9 years, 8 teams Births 2010/2009

2 Group 10 - 11 years, 8 teams Births 2008/2007

- 3 Group 12 - 13 years, 8 teams Births 2006/2005
- 4 Group 14 - 15 years, 8 teams Births 2004/2003
- 5 Group 16 - 17 years, 8 teams Births 2002/2001
- 6 Group 18 - 20 years, 16 teams Births 2000/1999/98

* Note: 2 Athletes born in 1997.

§ 2 - Professional amateurs and athletes may participate.

Art. 6° - Each team must have 1 member that will represent it.

Art. 7 - Teams may be entered with a minimum number of 15 (fifteen) and maximum of 25 (twenty five) athletes.

CHAPTER IV TEAMS

Art. 8° - INTERNATIONAL BASE FOOTBALL TOURNAMENT shall consist of a limited number of teams.

§ 1° The teams that will participate in the international tournament, if they do not have sufficient affiliates to train teams, may add athletes from other teams, provided they have previously been approved by the commission. The addition of these new athletes should happen after the registration period.

CHAPTER V TEAM REGISTRATION

Art. 9 - Participating in the tournament will be the teams that register through their representatives, within the period fixed and published by the organizing committee (12/09/18) deadline and final to register, provided that:

I - Meet the requirements for athletes, provided for in this regulation;

II - Declare to be in full agreement with the norms established for competition.

Sole Paragraph - The representatives of the teams will be responsible for the information regarding the athletes, as well as for the registration form of the team of their team, according to the registration form (Annex I of this announcement).

Art. 10^o - You can register as athletes:

Paragraph 1 - For registration, it is mandatory to fill out the form with the names and signature of the athletes, which must be submitted to the Organizing Committee and signed by the team representative.

§ 2^o The registrations for the tournament, will be given from the site, invitation letter or contact with the organizers by email, direct telephone or whatsapp, with time limit until 12/09/2018.

Art. 11 - Teams may not substitute or exchange players before the close of the tournament, except for just cause or force majeure, with express authorization from the Organizing Committee.

Paragraph 1 - The teams' lists will be made available on the official website of the event (TIBAU PIPA CUP), so that everyone involved in the tournament can be known.

Paragraph 2 - If the team plays with any athlete properly enrolled in another team, it will be eliminated from the tournament.

CHAPTER VI DISPUTE SYSTEM

Art. 12º - INTERNATIONAL FOOTBALL TOURNAMENT BASE will be played between the G1, G2, G3, G4, G5 and G6 keys:

I - System of 5 games each team - (2 more games until the final), Final Semi Final.

II - Two teams for the final dispute of each Group.

Art. 14 - The final phase will be played in a single game, by the two teams classified in the previous phase, being champion the winning team.

Article 15 - The results of the matches will be scored as follows:

I - The classification of the teams will be by points earned, adopting the following criterion:

- a) Victory 03 (three) points;
- b) Tie 01 (one) point;
- c) Defeat 00 (zero) point.

II - If there is a tie in the normal time in the semi final and final, there will be a penalty shootout with 5 charges. If it ends tied after the charges, the dispute will be in alternate charges.

CHAPTER VII PROGRAMMING OF GAMES

Art. 16 - The organizing committee of the event has already provided the date (October 12, 2018) for the tournament to be held in the TIBAU DO SUL - SEDE, PIPA AND GOIANINHA fields.

Paragraph 1 - The games of the tournament will be programmed in a table prepared by the organizing committee until October 11, 2018.

Art. 17 - Items scheduled in the table can not be transferred.

CHAPTER VIII RULE OF GAMES

Art. 18 - The games will have a duration of 30 (thirty) minutes, divided into two stages of 15 (twenty five) minutes, with 10 (ten) minutes rest interval for players from 08 years to 20 years, of children and girls will last 30 (thirty) minutes, divided into two stages of 15 (fifteen minutes, with 10 (ten) minutes rest interval for players from 08 years to 20 years.

The Grand Final of each group will have a duration of 40 (forty) minutes, divided into two 20-minute steps with a ten-minute rest

Sole Paragraph - In the field, teams must change sides to play the second stage of the game.

Art 19° - In exceptional cases, one of the teams or even the two, at the option of its representative, may play matches with at least 8 (eight) athletes.

Art 20° - The substitutions of the athletes will be allowed without limits of number, being able even the replaced one to return to the game.

Art 21° - The following cards will be adopted for punishment of the athletes during the games:

I - Yellow - Warning

II - Red - Expulsion of the game, the team not being able to replace the athlete.

Article 22 - In addition to the rules provided for in this chapter, FIFA rules shall be used provided they are not in conflict.

Art 23 - The team that does not play the scheduled match will automatically lose the game, registering on the scoreboard the score of 1 X 0.

Art 24 - The athlete punished during the match with red card will be automatically suspended from the next game.

Art 25 - The team that practice relative irregularity, the athlete's lineup, will be given victory to the opponent of the match.

Art 26 - The cases not covered by this regulation will be evaluated and judged by the Organizing Committee, and no appeal will be lodged against the decision.

Art 27º - This regulation shall apply to the INTERNATIONAL FOOTBALL TOURNAMENT 2018 BASE coming into force on the date of its approval by the Team Representatives.

Art 28º - The TIBAU PIPA CUP award will be distributed in:

I - 1 Champion Trophy and medals.

II - 1 Vice-Champion Trophy and medals.

III - 1 Top scorer's trophy of the competition.

IV- Certificate of participation of the International Tournament to all enrolled ones elaborated by the Municipal Secretary of Culture, Sport and Leisure.
